1. This agreement is for entertainment services for the event described above, between the undersigned purchaser of entertainment (**Client**) and **Budget Bride Professional DJ Service, Inc.** herein referred to as **BBPDJS**.

2. **BBPDJS** agrees to provide the **Client** for compensation certain entertainment services, which may include sound, background music, dance music, introductions and making announcements.

3. The **Client** agrees to pay the **non-refundable** \$250.00 retainer fee upon signing this agreement and to pay the balance due at least one (1) week before the wedding date. All payments are not transferable, not assignable, nor refundable. Balance is due in full if event is cancelled inside of 90 days of wedding date. If event is cancelled, for whatever reason, by **BBPDJS Client** will receive a full refund of all monies paid to the company.

4. Should the **Client** desire additional time beyond the contracted hours of service, the **Client**, the DJ and the facility must unanimously agree to extra time extensions. The **Client**

agrees to pay the **BBPDJS** DJ \$25.00 for each half hour of extra time. **Client** agrees that extended time payments must be paid to the DJ in cash prior to beginning the extended time period.

5. The **Client** is responsible and liable for the results and cost of any/all injury or damage by them, their guests and/or agents, **to BBPDJS** DJ, equipment, vehicles and peripherals.

6. Should **BBPDJS** become seriously ill or injured, suffer catastrophic equipment loss, a death of a parent, spouse, sibling or child, or other extraordinary unforeseen acts of God, nature and/or fate, **BBPDJS** agrees to take prudent action, circumstances permitting, to provide the **Client** with alternative choices and/or services.

7. **Client** satisfaction is guaranteed or the **Client** may request a partial or full refund of the total payment. The guarantee covers those actions and decisions that are under the **BBPDJS** DJ's control and supervision only. **Client** agrees to notify the **BBPDJS** of any dissatisfaction immediately. This guarantee expires **twenty-four (24)** hours from the conclusion of the reception.

8. **Client** agrees that any and all modifications to any portion of this contract by the **Client** must be submitted in writing, be approved in writing and must be initialed by **BBPDJS** or such modifications are invalid and nonbinding.
